

The final divorce hearings took place in late March 2006 and while waiting for the issuance of permanent orders, my wife and her friends launched an all out assault on each of my relationships with the children, especially the son that had had the suicide thoughts earlier that school year (This is also the time frame that the excessive scheduling of refereeing, sleepovers, alter boy serving, and other events, became unmanageable and caused each of my children to want to avoid being with me during my parenting time weekends):

Reporter Narrative:

Children were with FOC for a visit and FOC and the children were having a family meeting and did not want to answer FOC in fear that he may say the wrong thing and FOC got angry and shoved into some cots and hit his ribs and stated that his ribs hurt and the rib area was red. The other siblings witnessed what happened. When the children got home to their MOC, they told her what happened and MOC asked why they hadn't called her and the children said that FOC took the phone cord out of the wall and when they are with FOC he often does this so they can't call anyone. FOC has a history of DV and of being physical with the children. The children have told MOC that they are scared when they are with their FOC. They are afraid to say the wrong things when around FOC.

Date: 5/12/2006 Worker:

TC from FOC who states that the allegations from the report are false and he and MOC have been struggling ever since they divorced. FOC visits with children every other weekend and MOC has even been scheduling activities on his parenting time. FOC has family meetings with his children when they come to visit and has had the most problems with the divorce. uses foul language towards FOC and has even hit FOC. FOC states that it is true that did not want to respond when they were having the family meeting and was laying down on the cot and FOC wanted him to communicate and interact with the rest of his siblings so he grabbed Tyiers arms and pulled him to a sitting position. FOC did not shove. FOC also stated that the children do have access to the telephone and the children call and check in with MOC everytime they are at FOC's house. FOC states that before the divorce, was getting straight A's and is now having a hard time. All of the family are in counseling and FOC states that he loves his children and would never put them in the middle of the divorce or hurt the children in any way. FOC was very appropriate. FOC states that MOC has made false allegations against him in the past. I did advise of report and CAN laws and FOC understood.

(The first account of the alleged incident was by my wife (MOC – Mother of children) on 05/11/06. My response was on 05/12/06 and the case was immediately closed unfounded.)

Not able to end her scam, my wife contacted the Middle School Counselor, who called Social Services again, and as soon as they were able to find another caseworker willing to participate in the scam, my son, who was struggling academically, was taken out of school early and taken to the police department in my city and forced to make the false report again:

ON 051506 AT APPROXIMATELY 1500N HOURS, WHILE WORKING THE DESK, I SPOKE TO CAROL AND JANET . CAROL IS THE MOTHER OF AND JANET IS WITH THE JEFFERSON COUNTY SOCIAL SERVICES. ACCORDING TO CAROL, SHE NEEDED TO REPORT A CHILD ABUSE REGARDING . ACCORDING TO CAROL, SHE AND HER HUSBAND, JOHN , RECENTLY DIVORCED. CAROL SAID THAT THEY HAVE BEEN SHARING CUSTODY OF THEIR 5 CHILDREN, WHILE WORKING THROUGH THE JEFFERSON COUNTY COURTS. ACCORDING TO CAROL, ON 051306, SHE NOTICED A `MARK` ON BACK. SHE SAID THAT IT WAS AN APPROXIMATELY 2 INCH BY 1 INCH MARK, WHICH CAUSED HER CONCERN. CAROL WROTE A VOLUNTARY STATEMENT, WHICH WAS PUT INTO PAPER FLOW. CAROL INFORMED ME THAT JOHN LIVES AT

(In the first false report, my wife claimed that I had "shoved (my son) into some cots and (my son) hit his ribs and stated that his ribs hurt and the rib area was red." In this complaint, she states that "on 05/13/06 she noticed a "mark" on (my son's) back." If the dispatcher would have known about the previous claim to County Social Services, Carol and Janet would have been charged with false reporting, as it was clear that they were contradicting themselves.)

The next day a police detective was assigned and he and the county caseworker, who was, unbeknownst to me at the time, working very hard to aid and abet in a known crime, went to each of my children's schools and pulled them out of class to interview them:

On 051606 I was assigned this case. On 051506 the victim _____, his mother Carol _____ and Janet _____ from Jefferson County Social Services came to LPD to file a report of child abuse. _____ reportedly had slight discoloration on his back from what he thought might be from his dad John _____ throwing him against an army cot that he sleeps on at his dad's house. No CSI was available to take photos at this time as reported by the Desk Agent.

On 052506 Janet _____ and I drove to Evergreen to meet with _____ and his siblings. _____ has three brothers and one sister. Their names are _____ (13), _____ (11), _____ (9) and _____ (6).

We contacted _____ at _____ Middle School. I asked _____ what happened at his father's house

_____ I asked _____ if he thought his dad did this intentionally trying to hurt him. _____ said, 'I don't think so'. I asked _____ what happened after he fell *(The fooled detective did a very thorough investigation, not knowing that he was being conned the whole time by both the mother and the County Child Protection caseworker.)*

After the fiasco at the schools, the detective came to my apartment to interview me, and shortly after this, concluded his lengthy report:

Ms. _____ has brought video and pictures in of _____'s injury on 060506. The photos and video show a small abrasion on _____'s back. The video and pictures were booked in as evidence.

The child abuse report regarding _____ was made nine days after the incident occurred. There is no corroborating evidence to suggest John caused the injury intentionally or recklessly. This case is closed unfounded.

(It's a shame that this good detective, five children, and a good father, had to go through all this at the hands of two con-women and at the expense of the taxpayers – this is all too common.)

Not able to end her scam, the County Social Services' caseworker continued her harassment:

IBJECT: Child Abuse Report 6.14.06

A report was received **MESSAGE** that _____ was injured during a family meeting because you grabbed his arm and pulled him, causing _____ to get a scratch on his back from the cot. This is the same report that Det. _____ contacted you about. Child abuse laws state that parents cannot leave marks or injuries when using physical discipline.
