

Following the "911 Scam" on 03-18-06 and after receiving the 'Mandatory Criminal Restraining Order' against me, my wife tried twice to obtain further restraining orders to keep me away from the kids (Paragraph b involves the son that later had the suicidal thoughts):

VERIFIED COMPLAINT MOTION FOR CIVIL PROTECTION ORDER

4. a) The most recent incident that causes me to ask for a Civil Protection Order occurred on or about 3-18-05 (date), at about 1:45 p.m. (time), in Jefferson

(County), when _____ (name of party) did the following to me and/or the above named children. (Be specific: What was the threat or acts of violence? Where did this occur? Were the minor children present?): John + I had stipulated that he would live in the cabin located on our property, coming into the home only to use the bathroom + computer in office. He was in the house all day. He was video taping me, + packing + removing boxes down to cabin. Our home has no bedroom doors. I was in an upstairs bedroom when John shoved a dresser into me, shoving me into the wall. I hurt my shoulder back, hips, cut my finger, + hit my head against the wall. When I got free, I called 911 + John was arrested for domestic violence + a restraining order pursuant to 18-1-1601 was issued to me, however, it doesn't protect m

b) The most serious incident that causes me to ask for a Civil Protection Order occurred on or about Jan. 14, 2005 (date), at about 5:30 p.m. (time), in Jefferson

(County), when _____ (name of party) did the following to me and/or the above named children. (Be specific: What was the threat or acts of violence? Where did this occur? Were the minor children present?): John has been very controlling over me + the children. John came in the house + was sleeping on the couch + John picked him up off the couch + threw him on the floor. So he could sit on the couch. He has been in the past physically abusive + always emotionally abusive to all 5 children.

(On 02-02-06, the jury saw the videotape referred to in a) and acquitted me. The incident referred to in b) was made up and was not reported to the police when I called them on 01-17-05. The mother used this son over and over again to manipulate the parenting time order.)

e) Be ordered to have no contact with the minor children listed above and that I be awarded temporary care and control and interim decision-making responsibility for the children.

or That I be awarded temporary care and control of the children and that the other party be given parenting time with the children and interim decision-making responsibility as follows (be specific):

I make all decisions.

Supervised Parenting Time

f) Other: Be ordered to have a mental health evaluation assessment before any contact with the children.

I understand that once a Civil Protection Order is issued it cannot be modified or dismissed by me or the other party without permission of the Court.
